A cross-country ski training trip to West Yellowstone, Montana over the Thanksgiving period in 2023. I agree that I am alone responsible for my safety while participating in competitive events and training for competitive events and during recreational skiing and specifically acknowledge that the following persons or entities, including Nordic Fitness & Adventures LLC, the organizers, coaches, officials, any agent, representative, officer, director, employee, member or affiliate of any person entity named above, and any volunteer chaperones, are not responsible for my safety.
